VALE ROY WATSON
20th April 2020

Baseball WA is saddened to hear of the passing of Roy Watson, a former Claxton Shield representative and inaugural inductee of the Braves Legends Club.

Roy was much-loved by the Braves and he was inducted as a club legend in 2013. He spent many years playing baseball with the Braves, and he was a talented sportsman in both baseball and cricket.

Roy was playing cricket in Fremantle when he was introduced to baseball, and it wasn't long before he was a standout second baseman. He became the first state baseball player to be selected from Braves Baseball Club in 1954. He went on to win Braves batting awards in the 1958/59 and 1959/60 seasons, and he was a member of the Claxton Shield in 1954, 1955, 1957 and 1960.

One of the highlights of Roy's career was his outstanding 1957 Claxton Shield series, where he impressed in the field and at the plate. He collected six hits and five walks in two games against Victoria and NSW, and at the conclusion of the carnival he was selected to the All-Australian side as a second baseman. This marked the first time a Braves player won Australian selection.

Roy was a passionate sportsman who was one of only four players selected to represent WA in both cricket and baseball before 1960. He encouraged others to make the most of their time on the field and was a highly respected member of the baseball community.

We offer our condolences to the Watson family during this difficult time.



VALE JACINDA BARCLAY
14th October 2020

A standout Australian sportswoman, Jacinda grew up playing junior baseball in WA and made her state debut for Western Australia at the age of 15 at the 2006 National Championships.

She went on to play for the Australian Emeralds in five Women's Baseball World Cups, winning a silver medal at the 2010 World Cup in Venezuela. She also played professional football for the Chicago Bliss in the Legends Football League and Greater Western Sydney in the AFL Women's competition.

CHAIRMAN'S REVIEW



When I look back at the past year, I see considerable achievement while also acknowledging the disruption caused by COVID-19.

The board continued to focus during the year on the five pillars of our strategic plan – participation, high performance, club health, facilities and profile.

It was pleasing to see progress on the \$6 million upgrade of Baseball Park in Canning Vale. This has been a major undertaking and occupied a lot of time for board members and management. Baseball fans were able to enjoy greatly improved facilities in the 2019-20 season and further work has been undertaken since then. Baseball WA obtained a commitment to additional state government funding in mid-2020 which will allow us to make the ballpark even better.

It was also pleasing to see increased participation during the 2019-20 season, with extra teams in both the senior and junior competitions. Improving participation pathways and opportunities is one of BWA's main areas of strategic focus. This includes working with Teeball WA, schools and other organisations to generate grassroots interest and transition young players into baseball.

Reform of senior competitions is another focus

area. A sub-committee was established during the year to review issues and explore opportunities, such as promotion and relegation, and changes to mandatory grades. Its early days in this process and the board is keen to ensure all options are canvassed.

COVID-19 meant that finals could not be held in most grades. COVID also disrupted our winter programs and some elite development activities. While this was disappointing for many players and fans, the health situation left the board with no choice.

The Baseball WA Heritage Committee achieved notable progress during the year. The Heritage Committee's goals include increasing awareness of the history of baseball in WA, and ensuring high achievers are duly recognised through Life membership or Hall of Fame membership. The committee also seeks to ensure the history of baseball is properly recorded.

As a not-for-profit community sporting association, Baseball WA's goal is to ensure we have sufficient funds to sustainably deliver our programs. In support of this goal, we recorded a healthy surplus for the past year. This was distorted somewhat by the large inflows and outflows for the ballpark development. The board has continued to focus on careful budgeting and financial management. We received continued financial support from Healthway and the Department of Local Government, Sport and Cultural Industries, which we greatly appreciate. We are well placed financially for the future.

Two new members joined the board during the year. Jason Hewitt and Rod Bacon have brought extensive experience of baseball in WA. Their deep knowledge has complemented the contributions of other board members. We also farewelled Susan Butler.

Finally, I wish to thank all board members, our chief executive Lachlan Dale and all of the hard-working volunteers for their contribution to baseball in Western Australia.

CEO AND COMPETITIONS



First of all, I would like to give special Thanks to the Clubs, Volunteers, Supporters and committee's within Baseball WA. Without the time, passion and dedication from you, the game we all love, would not be as successful as it is.

I would also like to thank the staff who work tirelessly on providing support and guidance to clubs and members throughout the year. Most of their work is behind the scenes when nobody is around with the main objective of delivering better outcomes for the baseball community.

I also want to thank the Board of Baseball WA for their leadership of our game. With two new members covering a wide skill set, they will continue to plan for the future and guide new initiatives to ensure WA is progressive and leading the country in its delivery.

I'd also like to thank the Perth Heat. To Rory, Christian and Michael, thank you for seeing what we've seen for years, Baseball is the greatest sport in the world and with your support, investment, guidance and leadership we are looking forward to seeing it back to its rightful place in the WA Sporting Landscape.

Since the last Baseball WA Annual Report, I want to take some time to mention some of WA's key highlights.

At the turn of the new year, we saw both WA Under 16's and 18's compete at the National Championships held in Geelong, Victoria. With the Under 16's taking home 4th, the Under 18's won the championship in a thrilling 11-9 win over Queensland to bring the title home to WA. Unfortunately the Women's and Youth Championships were cancelled due to Covid-19.

Like the rest of the world, Baseball WA was unfortunately affected by the global pandemic of Covid-19 which saw the immediate cancellation of sporting competitions around the State of WA in March, meaning we were unable to host the Grand Finals and pinnacle of our club season. We understand the disappointment of our members missing out of the final game of the season and hope that the decision can be accepted as we all did our part to minimize the spread of the coronavirus. We look forward to the future season and we're sure with a new perspective on life our clubs and members will enjoy a summer of Baseball.

Subsequently, Covid-19 also meant a postponing of the Charter State Championships, normally slated for the Easter weekend. Machine Pitch, Development Shield, Little League, Intermediate League and Senior League were all affected and fortunately we were able to re-schedule these tournaments in the July 2020 school holidays. A reduced schedule due to restrictions meant 27 teams instead of the normal 40 plus competed for the title of State Champions. Congratulations to the winners in Little League Majors – Eastern Phantoms, Intermediate League – Western Suns (Eastern Phantoms/Swans Hills), Junior League – Northern Metros, Senior League – Wester Meteors (Central Firebirds/Southern Hills Warriors). Well done to the players and also to Morley Eagles Baseball Club who under tremendous circumstances hosted a terrific event with strong support from Perth and Wembley Baseball Clubs.

As part of drive for elite athlete performance and coaching we have continued developments of our elite programs with input from Team Australia, MLB clubs, WAIS and the Perth Heat. WA's relationship with the Tampa Bay Rays reaches beyond just the prospect players they send, we will be working

closely with them on sports science, baseball technology, coach development and player management systems to ensure our local players lead the Perth Heat both on and off the field. The by-product of this program will be athletes in collegiate, professional, national and State League programs. In 2020 we also launched our Futures Lite program aimed at 12-15 yo athletes to establish some fundamentals of high performance focusing on the core attributes of an elite athlete both on and off the field.

In November, our National Men's team came under manager David Nillson to compete at the Premier 12. WA Players Tim Kennelly, Robbie Glendinning and Daniel Schmidt (debut) played a huge part in the success winning through to the Super Round and beating the title favourites USA 3-1.

It is not just on the field that we are achieving success, off the field WA has seen some ground-breaking developments as well. Over the past 5 years, 90% of clubs have invested in capital upgrades at their home grounds, whether that be back nets, batting cages, dugouts or club houses we are seeing facilities improve. This all supports the opportunity to increase the game day environment to ensure our clubs are full with members and spectators enjoying the best atmosphere possible.

As many are aware, siteworks at Baseball Park have continued into the new season with practical completion and handover in October 2019. This has been the largest capital investment to baseball in this state for 30 years. I'm sure all fans can attest that the new grandstand, corporate and function areas, seats, changerooms, car park,

ticket gate, family areas and concessions are a fantastic addition to the Ballpark which is now the best in the country and will attract national and international baseball events. Additionally, we have secured Tom Bateman House which connects to the Ballpark and will serve as the new Baseball WA Administration Office in 2021

I would like to formally recognise the State Government's significant contribution towards these initial upgrades and the Federal Governments investment was we move into our final stage on the build. A special thank you Ken Wyatt for his ongoing support

Furthermore, I'd like to thank our major commercial partners, Department of Local Government, Sport and Cultural Industries, Healthway and its Think Again message, Perth Harley-Davidson, City of Gosnells, Fielders Choice, Nexus Risk Services and the Perth Heat.

On a final note, thank you to everyone in the baseball community for their time, effort and passion for the game especially in the most difficult times that participation sport around the country has faced. As an organisation, we continue to set high expectations to grow the game in WA and with passionate people not only at clubs but the wider baseball community, WA will continue to shine and be the benchmark in Australia.

As I hope you are, we're looking forward to the new success that we all achieve together in the 2020 / 2021 season and beyond.

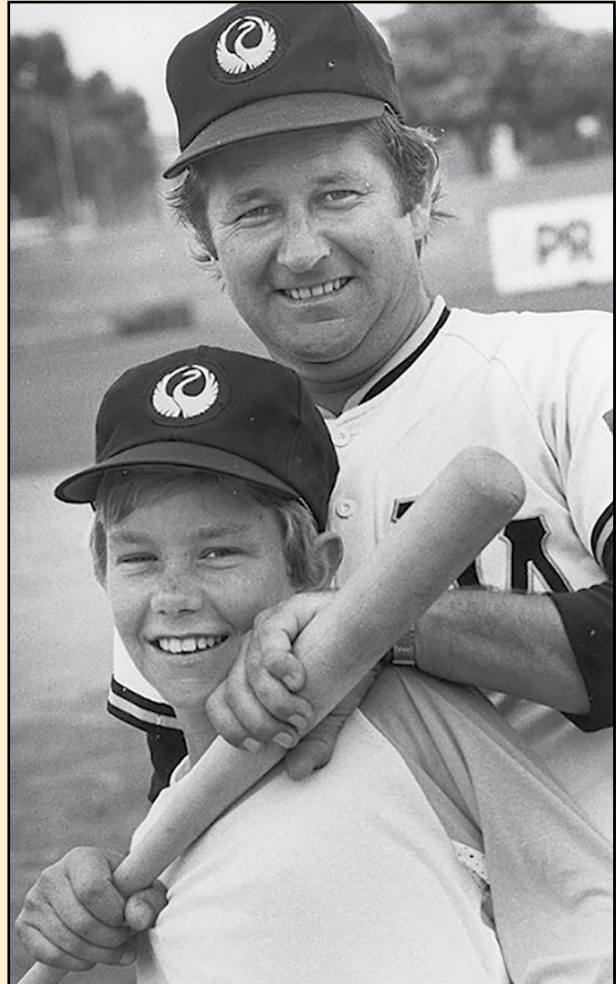
NEW LIFE MEMBER

UMPIRE ADVISER

Pre-season training was again predominantly conducted at Perth Modern School. These facilities are perfect for our training programs and my thanks go again to Chris Rapley for making the venue possible and for his great assistance in running the program. Our regular Rules & Mechanics nights were again conducted at Balcatta Baseball Club and were extremely well supported by our members.

We had a great influx of new junior umpires this year; most of them will be umpiring junior games within their own clubs but we really hope to see many of them umpiring in our senior ranks in the near future. We also had a few new senior umpires join our ranks and they performed really well in their 1st year. Look forward to bigger and better things next season.

While there is never enough time to work on all the different areas of umpiring, we continue to concentrate on the strike zone and gaining as much consistency as possible across each umpire. We all know that every umpire has a slightly different perception of the zone but consistency across the whole game is really important. Brett Robson, Chris Rapley, Peter Bowie and I spend a lot of time at pre-season training with consistency in mind. I would also like to acknowledge and thank Simon and Calvin Eissens, and Adam and Dan Stephenson for their work during the training sessions.

PONY GIRLS FUTURES PROGRAM BRINGS JUNIOR GIRLS TOGETHER ON THE FIELD

The 2020 Pony Girls Futures Program is off to a terrific start, with 49 girls ages 10-14 participating in the eight-week development season.

Formerly known as the Youth Girls Development Program, Pony Girls Futures gives junior players the chance to grow and develop on and off the field as they learn more about the sport and their athletic abilities. In this all-girls environment, game scores are not kept, so coaches can introduce players to different positions and give them the chance to try pitching, catching and fielding.

Players are split into four teams, train once a week and play games on Sunday afternoons, following the Spring Training sessions to start the season at the Baseball Park. They are led by four capable coaches: Conor Lourey, Andrew Cooke, Andy McDonough and Mel Edgar.

"We are pleased to have a great group of girls for the Futures program and it's awesome to see their progress and how much fun they are having on the field," Baseball WA Participation Program Manager David Hayes said. "We look forward to the rest of the year and encouraging these awesome athletes to keep working hard at their goals."





ATHLETICS' CLOSER LIAM HENDRIKS WINS AL RELIEVER OF THE YEAR AWARD

Liam Hendriks, who has gone from the designated for assignment list to being the stalwart of the Oakland bullpen in the last two years, was named the 2020 Mariano Rivera American League Reliever of the Year Saturday.

In a season shortened to 60 games by the COVID-19 pandemic, Hendriks converted 14 of his 15 save opportunities for the A's. He blew a save on opening night, but the A's came back to win the game on Matt Olson's grand slam in extra innings against the Angels.

From that point on, Hendriks was a perfect 14-for-14 in saves, finishing second in the Major Leagues in saves, thanks in large part to a 1.78 ERA.

"Honored is an understatement," Hendriks said in a statement released by Major League Baseball. "It's humbling to win an award that bears the name of the greatest closer in history.

"I'm extremely thankful to my teammates. If they weren't behind me on the field, I wouldn't be half the pitcher I am today. A huge thank you to the bullpen for sharing years of invaluable advice and experience with me. Thank you to the coaching staff and the entire organization for believing in me and giving me the opportunity to play in the green and gold."

- Research, promote, circulate, preserve and display the history of Baseball in Western Australia.

BACKGROUND

The BWA Heritage Committee was formed in February 2018 to address the purposes as outlined above. The Committee meets on a quarterly basis (four times a year) and has an established Terms of Reference. The Chair of Baseball WA (BWA) is also the Chair of the Heritage Committee so that the reporting structure of the BWA Board is ongoing.

ACHIEVEMENTS

1. *Nomination to the Australian Baseball Hall of Fame*

In 2019, South Perth, WA Claxton Shield, Perth Heat, 2000 Olympic representative and San Diego Padres pitcher, Mark Ettles was successfully



inducted into the Australian Baseball Hall of Fame to complement 14 other West Australians already inducted into the Hall of Fame.

In 2020, Neville Pratt was submitted as the WA nomination. Neville had a distinguished playing career with Nedlands Baseball Club, WA Claxton Shield and National teams and was a 1956 Melbourne Olympic representative. He also had a distinguished administrative career in Australian and International baseball and was instrumental in positioning Australia on the international baseball landscape.

2. BWA Life membership

In October 2020, Mr Darryl Moyle was inducted as a Life member of Baseball WA during a ceremony at the Harley – Davidson Ballpark. Due to the COVID restrictions, the Annual BWA Awards Night was cancelled in March 2020 where the recipient would have been acknowledged in a formal occasion.

Mr Darryl Moyle joins an illustrious number of recipients who have been awarded Life Membership for their valuable contribution to the development of playing, coaching and administrative facets of baseball at the Club level, State and International level.

3. BWA Hall of Fame

During 2020, the Heritage Committee became aware of a gap that existed between BWA Life Membership and the Australian Hall of Fame. It was evident that there were a significant number of baseball players who had made valuable contributions at State League Club, State and International baseball who were not be able to fulfil the criteria for nomination to the Australian Hall of Fame.

In April 2020, a sub-committee, under the direction of Don Knapp, was formed to investigate the feasibility of introducing a Baseball WA Hall of Fame. In October 2020, the BWA Board



approved the Charter and Terms of Reference for State League to submit nominations by the end of November 2020.

An Initial Selection Panel (ISP) is tasked with reviewing all the nominations and making recommendations for BWA Board approval. A formal induction ceremony will occur in February 2021 to officially induct members into the BWA Hall of Fame. In the future, new members will be inducted on an annual basis.

4. Museum & Archives Project

In 2018, BWA was cognisant that baseball volunteers were historically the collectors, compilers and custodians of community club records and that, with the aging and passing of many club stalwarts, the loss of records and other baseball artefacts of significance were disappearing to the wider baseball landscape.

In May 2018, the Heritage Committee agreed to be the 'pilot organisation' in conjunction with the Centre for Sport and Recreation Research at Curtin University, to undertake the development of 'a guide' in Collections Management to assist organisations in decision-making regarding 'what do we have?' and 'what should we do with it?'

Following the research findings, it was determined that BWA should implement an archival

program to ensure that baseball memorabilia was made available to the baseball community. In March 2020, a building was identified at the ballpark as suitable to house a small baseball museum.

The BWAHC has approved several policies to ensure that strong governance of the project is maintained.

On completion of the renovation the museum and archive project was officially opened in October 2020 by the Hon. Ken Wyatt, Federal Minister for Indigenous Affairs and now houses a solid collection of baseball memorabilia.

At the same time, six volunteers agreed to be part of an Archival Program to ensure that the memorabilia was correctly catalogued, digitised, displayed and stored. Currently, they volunteer their time once a week to ensure there is continuity with the project. They have been comprehensively involved in the development of the Museum and Archive Strategic Plan for the next 3 years.

Baseball WA is very appreciative to the number of information service providers in Perth who donated resources and equipment for the project. In addition, the project would not have proceeded without the generous financial support of the Richard Lockwood Charitable Foundation (UK).

The 2019-20 ABL season brought some amazing moments and some challenging hurdles as well, such as the case with any sporting season. While we fell short of our goal of winning an ABL Championship, we were right in the mix throughout the season, and were one pitch or one swing away from getting over the line. We lost a few heartbreaking games along the way, but I really liked our chances in a 3-game playoff series with anyone, so when we were relegated to the Wild-Card game (by rule), it became anyone's race, and we didn't perform as well as we had hoped.

Our Captain, 'TK', showed once again why he is the leader for our Perth Heat ... and for Team Australia. He brings a balance and work ethic to the park like very few and is a true leader by example. When you have effort at the top from a guy like Tim, it makes everything else a little bit easier. This guy still runs out every ground ball, every fly ball, like it may be the last day he ever plays the game. He respects the game, and it shines in everything he does. We are lucky to have this man in our clubhouse and he is a rock in our lineup.

Robbie Glendinning had another great season for our club, and was a heavy consideration for the league MVP. His numbers were clearly indicative

of a deserving recipient. He has a real aptitude to hit a baseball, plain and simple. He's really developed on defending the running game and picked off the league's MVP at least twice. That's been a game-changer for him, and for our club.

I was really proud of Josh Hendrickson this past season as well - he had some sincere personal growth and took it straight to the mound. While only having limited appearances with our club due to innings restrictions, he answered the call and showed an intensity and fire that dominated opposing bats in his latter appearances. We talked about his mindset, and he stepped up and showed what we felt he was capable of doing. His pro career is going to be fun to watch.

Alex Hall's work ethic is really impressive. From an intent perspective, Alex does everything he can to prepare himself to be successful. He loves the gym, arrives early to the park, and is constantly focused on working at his craft. He continues to develop behind the plate and with continued work on the block and the receive, Alex could be a mainstay in the Heat's future.

Ulrich Bojarski delivered some big swings and can wow at times with some eye-popping 'man strength'. He's still working to use the other side of the field at the plate, and needs to continue to get reps defensively, but the bat can be down right scary at times. The ceiling is high for young Ulrich.

Jess Williams added so much to our clubhouse... he has an amazing energy that lifts the spirits of those around him. He's a versatile player, and when he's seeing the ball well, he can really do some damage. A guy who takes the extra time to say 'hello' & 'goodbye'...a guy who cares about his teammates (and they equally love him). With some added strength to his frame in this unprecedented 'off-season', Jess could position himself very well for his future.

Sam Kennelly gave us some much needed punch at the end of our lineup in the latter half of the season. Another team guy with a phenomenal attitude, I really believe Sam's bat can make him an everyday guy in the ABL As he continues to develop and work on his game defensively, Sam shows some sneaky pop that can change games.

The most inspiring takeaway for me was the emergence of a few new names that could really provide a core nucleus in Perth in the years to come. A healthy Mitch Neunborn stormed onto the scene with some electric stuff on the mound. A low 90's fastball and two secondary pitches that already show real promise, Mitch is going to help our Heat, and potentially Team Australia, win baseball games. He brings a great attitude to the park and is a team guy first, and I can't wait to see what he is going to do in Professional baseball. Josh Rawlinson got better and better every outing, and in hindsight, could have been utilized in a greater capacity. Mid-90s fastball over the top, a developing slider (OTT that changed his attack on LH bats), with the ability to drop down for a very different look, he was really tough on opposing bats at times. If he can keep his stuff where it was at the end of the season, he's always going to be in the discussion for Team Australia.

Conor Lourey, Tom Bailey, & Nick Veale all provided some key innings for us. All three of these guys had some dominating moments, as they all love to compete. Conor was battling through some arm stuff, and fought hard to deliver for our club while he could. It was really exciting to see Tom come back strong after a long-road, and it is obvious he really loves to pitch - he's fun to watch and prepares like a professional. Nick can make hitters look foolish with his above-average change up and offered up some key innings for us. A healthy and performing Cameron Lamb is also a consideration for the future of the Heat.

Other rising stars that are going to be fun to watch are young Will Sheriff, Mitch Schofield, Jake Turnbull, Jake Bowey, Byron Armstrong, Jack Bowins, and Liam Collins. Although a couple of these guys may not have had all the opportunities they would have liked with the huge Rays contingent we had this past season, if they continue to stick with it, and work hard at their craft, there is no reason they can't be in the mix in the future.

We enjoyed a great relationship with the Rays and surely hope to continue to do so going forward. They sent us some really great people, and it was a joy to work with both the players and the coaches of the Rays organization. Coaches Report

The under 16's team under Head Coach in Peter Torpy along with Pitching coach and assistant from the previous two years Arnie Noel, Kent Fitzgibbons and new coach to the program, assistant coach Kurt Russell.

The program started with the selection process on Saturday the 12th of September and had a total of 55 players register for selection. Over the selection process we took the approach of seeing the players in games until we got down to the final 30 players. We could see that the team was starting to stand out as a heavy second year player group, so we choose to include 6 first year players as train-on for experience. With our training, South Perth Baseball Club once again took us in as our venue during the week and their facilities and hospitality were outstanding. Due to the inexperience of the players in a High-Performance capacity we knew we needed to spend a lot of the training session with plays and general baseball knowledge rather than bull pens, so we had another session at Baseball Park on a Wednesday night for Bull pens which was a fantastic success.

Team final team travelled to Geelong, Victoria. Game 1 was a thriller with a walk off win against eventual winners Queensland 5-4. Jaxon Limpus with the single in the bottom of the 7th to win it. Limpus led the team with 2 hits. Caleb Goodwin had the start throwing 3.1 innings 3 hits 2 runs with 3 strikeouts. Ben Randall and Taj Schofield were fantastic out of the pen each throwing scoreless 1.1 innings. Our first double header was Day 2, unfortunately going down to CNSW 8-3. 3 errors cost us in this game. Hits to Cameron Landy, Jacob Santich, Ethan Oliphant and Ben Bird. Flynn McGahan got the ball and pitched 2.2 innings for 2 hits, 1 ER and 6 SO. Game 2 of the Double header saw errors and walks being the problem in a blow out. Beating ACT 17-13. 3 hits to Lewdon TeMara, and 2 hits each to Flynn McGahan, Reily Marsh and Ethan Oliphant.

Day 3 saw us go down to South Australia 5-3. We had our opportunities to win but left it too late. With

bases loaded in the last and the tying run on 2nd we couldn't get it done. 4 errors didn't help the cause. Hits to Lewdon, Josh Davies, Tyson Noel and Oliphant the shining light. Daniel Meloncelli had the start and was fantastic 2.1 innings 2 hits, 2ER 2 BB and 1 SO. With Taj Scholfield, Cameron Landy and Kaine Newham each providing strong relief work. In a must win game to keep our Gold medal game hopes a live we blew Vic Blue out 18-6. A massive day at the plate for Jaxon Limpus 5 for 5 with 2 runs and 4 RBI's. Noel threw a blinder 4 innings 9 hits and 4 ER with 4 SO. Then following up with Vic White in the afternoon winning 10-4. Limpus continued a very strong day collecting another 3 hits and 3 RBIs, supported by Aiden Browne and Finlay Duncan with 2 hits each.

In the last day of round robin before the medal games we went down to NSW 14-6. Landy the only batter with a multi hit day. Making it through to the Bronze medal game against South Australia almost mirrored the round robin game. Going down 5-3 in a shorten game due to the smoke haze. Again having the tying run on second base with the final out was made. We did all our scoring in the top of the last inning and just ran out of outs and time. Hits to Landy, Santich, TeMara and William Truscott were not enough.

We look in hindsight and where we finished was probably about where WA does stand in terms of the rest of the country in this age group. A look at tinkering with our program will only help develop our players. The bullpen sessions on their own night was a complete success. While the coaching staff sat to work out an MVP it was extremely hard but Jaxon Limpus who hit .462 with 3 doubles and 11 RBIs really held the offense together while making some extremely good defensive plays in Right Field. .

Medical Report

I would like to begin my report for 2020 Nationals by saying a sincere thank you and congratulations to all of the coaching staff of the Under 18's and Under 16's teams, our wonderful Executive Officer Deanne Saupold, Lachlan Dale from Baseball WA, Sharon Butty from Baseball Australia, Perth Heat baseball team and the staff at the Geelong accommodation we stayed at. The help that was received from these people was amazing when we were dealing with a major event in the Final of the Under 18's and after the tournament. Everyone went above and beyond to assist us.

This year we were fortunate enough to have a fully qualified Physiotherapist travel with us as the medical person for the Under 16 team.

The fires that surrounded Geelong did not seem to have a negative effect on our team health wise and Baseball Australia did everything they could to keep us informed and the players safe. Games were reduced in time and locations changed if needed. The under 16 team did play at Altona were the conditions did get worse during their game and one player was affected by the smoke haze.

PRE TOURNAMENT:

During the Pre Tournament series Hanna and I were able to complete rehab sessions with all the players from the 16's and 18's teams who needed it.

Pitchers and catchers were asked to wear compression after they threw and to also ice after an outing.

Those with niggles or injuries were referred to the list of Physiotherapists sanctioned by Baseball WA.

A couple of players were getting treatment from physiotherapists during the Goodwill Series and they were told that they needed to get signed off by the Heat Physiotherapy Staff and then give myself a letter from their physio outlining the rehab that was needed to be continued for them over the tournament. They all complied to this request.

TOURNAMENT PHASE:

Both WA teams travelled to Nationals with a fully fit compliment of players. All players had been following the Strength and Conditioning programs developed for them by BWA and our Coaching staff.

On day 1 one of the Under 16 players re injured an old injury and had to be rested for a number of days. He was seen by the Tournament Medical staff and given a clearance for day missed from play. He then had to undergo a Fitness test to be cleared to play for the rest of the tournament. Which he passed.

Another Under 16 player had to be assessed by tournament officials due to an injury received in a game and he was cleared to play after a couple of days off.

During the tournament a number of players came to the treatment room for massages on legs and lower backs, arms and shoulders due to general match play soreness, which is understandable in a Championships format of play. As the tournament progressed this number gradually increased as was to be expected.

Some of the 16's players were receiving massages to relieve the aches and pains of tournament baseball at this stage.

A couple of players in both teams had regular strapping applied for the entire tournament: Ankles, knees, elbow and wrists.

A number of grass burns occurred over the tournament ... these were patched for the game quickly and then treated after the game. Treatment consisted of: cleaning the wound with water and Dettol with gauze, wiping over with Betadine and then applying Fixomul dressing to the site (this was to stay on until the dressing fell off). For play the dressing was covered with an Adhesive bandage, a 'square' or 'circle' (a type of adhesive second skin) and then removed after play. If the wound cover was dirty the site was redressed and cleaned. No infections developed over the ten days and all sites appeared to heal well.

All players responded well to treatment and rehab sessions which were completed at the accommodation in the pool. We had all players available to play in the Gold medal game for Under 18's. The under 16's had a full compliment available too for the Bronze Medal game.

All pitchers completed their pitching rehab sessions after their appearances and received regular massages and therapy sessions in between assignments.

During the Final of the under 18s we had a couple of incidents, one being very major resulting in our player having to stay in Melbourne until he was deemed fit to fly by the hospital.

First incident was when our catcher wore a pitch to the throat, the ball bounced under his throat guard and literally took the wind out of him. He was checked onfield for any damage to his trachea and larynx. He was given the all clear by myself and the Tournament official Medical person. The player was monitored for the rest of the game closely.

The next incident occurred when one of players was going for a ball and had a collision with a team mate who was also going for the ball.

Player A stayed on the ground for a long time, the umpires called time for me to go and check the player which I did. I did a full body check as the player was visibly distressed after the collision and had not moved. He stated that he was feeling winded and he was in some discomfort. I suggested that he come from the field and be replaced but he wanted to play on. I discussed my view with the head coach and stated that I did not think the player should continue in the game. But the player assured me he was ok. So he played on. During the players at bat he was very uncomfortable swinging the bat and on his return to the dugout I insisted that he take no further part in the game and go to hospital to be checked out. This decision got met with a NO from the player as we only had two digs to go in the game and the on the games conclusion he would go to the Doctors/hospital. I monitored that player for the rest of the game and took appropriate action.

After the game the player in question became more distressed and we advised his father to take him to hospital as his condition was getting worse. On arrival at the hospital the player was

admitted to ICU after it was discovered he had a lacerated spleen and broken ribs from the collision. Fortunately the ER doctor had said that all the treatment the player was given in the lead up to going to hospital had slowed down the bleeding. This player was required to stay for another week in Victoria due to not being able to fly.

His mother was flown over with the Perth Heat team who were playing in Geelong. His father remained with him and we arranged for them to stay at our accommodation.

Baseball Australia were in constant contact with us and helped with Insurance arrangements. They went above and beyond.

We also had another player hurt their arm in the outfield whilst throwing a ball into the infield and he was taken from the game and treated for an arm strain.

In the last innings we were notified by ASADA that two of our player would be drug tested after the game. We asked that they not be notified until the end of the game of which the official complied to our request.

These boys were allowed to participate in the celebrations post game and then were accompanied by myself to their tests.

All boys showed the utmost respect when attending treatment and where completely honest when reporting issues of injuries or soreness.

The travel between venues did not seem to impact the players.

I was very proud of the young men I was lucky enough to travel with and they were a credit to WA Baseball and their families. Congratulations on the success of both Teams.

It was fantastic to be a part of the Gold Medal winning Under 18 team and the Bronze play off Under 16 team.

He worked four innings, striking out six and not allowing a run or hit.

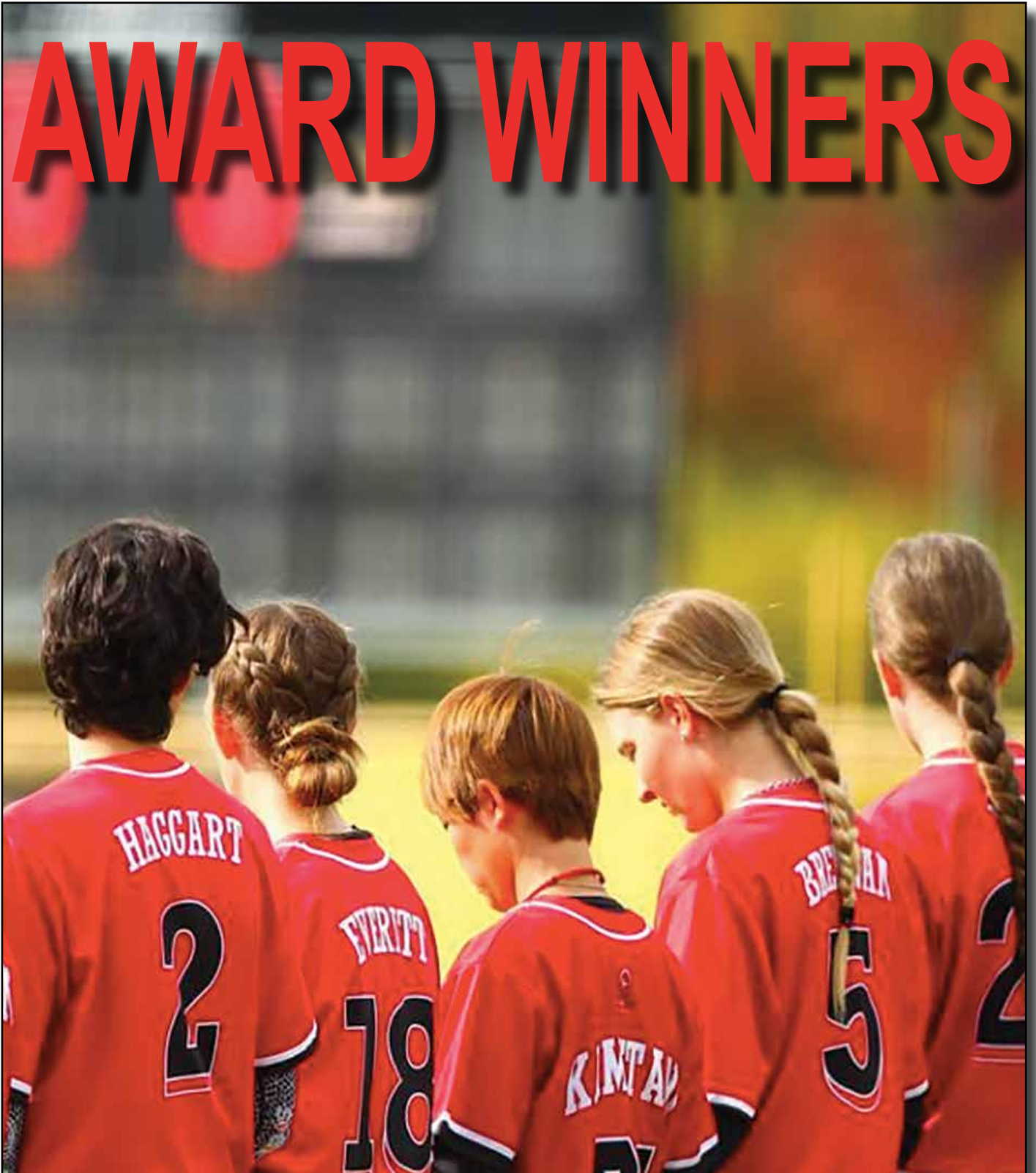



The financial statements cover Baseball WA Limited as an individual entity. Baseball WA Limited is a not for profit company limited by shares incorporated under the Corporations Act 2001.

The functional and presentation currency of Baseball WA Limited is Australian dollars.

Comparatives are consistent with prior years, unless otherwise stated.

1 Basis of Preparation

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Corporations Act 2001. The Board has determined that the company is not a reporting entity.

In the opinion of the Board of Directors, the company is not a reporting entity since there are unlikely to exist users of the financial report who are not able to command the preparation of reports tailored so as to satisfy specifically all of their information needs. These special purpose financial statements have been prepared to meet the reporting requirements of the Act.

The financial statements have been prepared in accordance with the mandatory Australian Accounting Standards applicable to companies reporting under the Corporations Act. The company has complied with the recognition and measurement criteria of Australian Accounting Standards.

The financial statements have been prepared on an accruals basis and are based on historical costs modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

Significant accounting policies adopted in the preparation of these financial statements are presented below and are consistent with prior reporting periods unless otherwise stated.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of this financial report.

2 Summary of Significant Accounting Policies

Property, plant and equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment losses.

Property

Freehold land and buildings are carried at their fair value (being the amount for which an asset could be exchanged between knowledgeable, willing parties in an arm's length transaction), based on periodic, but at least triennial, valuations by external independent valuers, less subsequent depreciation for buildings.

Increases in the carrying amount arising on revaluation of land and buildings are credited to a revaluation surplus in equity. Decreases that offset previous increases of the same asset are charged against fair value reserves directly in equity; all other decreases are recognised in profit or loss.

Any accumulated depreciation at the date of revaluation is eliminated against the gross carrying amount of the asset and the net amount is restated to the revalued amount of the asset.

Plant and Equipment

Plant and equipment and leasehold improvements (including baseball park) are measured on the cost basis and therefore carried at cost less accumulated depreciation and any accumulated impairment. In the event that the carrying amount of plant and equipment is greater than the estimated recoverable amount, the carrying amount is written down immediately to the estimated recoverable amount and impairment losses are recognised either in profit or loss or as a revaluation decrease if the impairment losses relate to a revalued asset. An assessment of recoverable amount is made when impairment indicators are present.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the company and the cost of the item can be measured reliably. All other repairs and maintenance are recognised as expenses in profit or loss during the financial period in which they are incurred.

Depreciation

Plant and equipment is depreciated on a straight-line basis over the asset's useful life to the Company, commencing when the asset is ready for use. At the end of each annual reporting period, the depreciation method, useful life and residual value of each asset is reviewed. Any revisions are accounted for prospectively as a change in estimates.

Fair Value of Assets

The Company measures some of its assets at fair value. Fair value is the price the Company would receive to sell an asset in an orderly (i.e.unforced) transaction between independent, knowledgeable and willing market participants at the measurement date.

Inventories

Inventories are measured at the lower of cost and net realisable value. The cost of manufactured products includes direct materials, direct labour and an appropriate proportion of variable and fixed overheads. Overheads are applied on the basis of normal operating capacity. Costs are assigned on a first-in, first-out basis.

Financial Instruments

Financial instruments are recognised initially using trade date accounting, i.e. on the date that the company becomes party to the contractual provisions of the instrument.

On initial recognition, all financial instruments are measured at fair value plus transaction costs (except for instruments measured at fair value through profit or loss where transaction costs are expensed as incurred).

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. They arise principally through the provision of goods and services to customers but also incorporate other types of contractual monetary assets.

After initial recognition these are measured at amortised cost using the effective interest method, less provision for impairment. Any change in their value is recognised in profit or loss.

The company's trade and most other receivables fall into this category of financial instruments. Discounting is omitted where the effect of discounting is considered immaterial.

Significant receivables are considered for impairment on an individual asset basis when they are past due at the reporting date or when objective evidence is received that a specific counterparty will default.

The amount of the impairment is the difference between the net carrying amount and the present value of the future expected cash flows associated with the impaired receivable.

For trade receivables, impairment provisions are recorded in a separate allowance account with the loss being recognised in profit or loss. When confirmation has been received that the amount is not collectable, the gross carrying value of the asset is written off against the associated impairment provision.

Subsequent recoveries of amounts previously written off are credited against other expenses in profit or loss.

In some circumstances, the company renegotiates repayment terms with customers which may lead to changes in the timing of the payments, the Company does not necessarily consider the balance to be impaired, however assessment is made on a case-by-case basis.

Available-for-sale financial assets

Available-for-sale financial assets are non-derivative financial assets that do not qualify for inclusion in any of the other categories of financial assets.

Purchases and sales of available-for-sale investments are recognised on settlement date.

Available-for-sale financial assets are measured at fair value, with subsequent changes in value recognised in other comprehensive income.

Gains and losses arising from financial instruments classified as available-for-sale are only recognised in profit or loss when they are sold or when the investment is impaired.

In the case of impairment or sale, any gain or loss previously recognised in equity is transferred to the profit or loss.

Losses recognised in prior period income statements resulting from the impairment of debt securities are reversed through the income statements, if the subsequent increase can be objectively related to an event occurring after the impairment loss was recognised in profit or loss.

Impairment of Non-Financial Assets

At the end of each reporting period the Company determines whether there is an evidence of an impairment indicator for non-financial assets.

Where this indicator exists and regardless for goodwill, indefinite life intangible assets and intangible assets not yet available for use, the recoverable amount of the asset is estimated.

Where assets do not operate independently of other assets, the recoverable amount of the relevant cash-generating unit (CGU) is estimated.

The recoverable amount of an asset or CGU is the higher of the fair value less costs of disposal and the value in use. Value in use is the present value of the future cash flows expected to be derived from an asset or cash-generating unit.

Where the recoverable amount is less than the carrying amount, an impairment loss is recognised in profit or loss.

Reversal indicators are considered in subsequent periods for all assets which have suffered an impairment loss except for goodwill.

Accounts Receivable and Other Receivables

Accounts receivable are recognised initially at the transaction price (i.e. cost) and are subsequently measured at cost less provision for impairment. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

At the end of each reporting period, the carrying amount of accounts receivable and other receivables are reviewed to determine whether there is any objective evidence that the amounts are not recoverable. If so, an impairment loss is recognised immediately in income and expenditure statement.

Employee Benefits

Provision is made for the company's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be wholly settled within one year have been measured at the amounts expected to be paid when the liability is settled.

Employee benefits expected to be settled more than one year after the end of the reporting period have been measured at the present value of the estimated future cash outflows to be made for those benefits. In determining the liability, consideration is given to employee wage increases and the probability that the employee may satisfy vesting requirements. Cashflows are discounted using market yields on high quality corporate bond rates incorporating bonds rated AAA or AA by credit agencies, with terms to maturity that match the expected timing of cash flows. Changes in the measurement of the liability are recognised in profit or loss.

Provisions

Provisions are recognised when the company has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

Cash and Cash Equivalents

Cash and cash equivalents comprise cash on hand, demand deposits and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value.

Revenue and Other Income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the Company and specific criteria relating to the type of revenue as noted below, has been satisfied.

All revenue is stated net of the amount of goods and services tax (GST).

Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.

Rental income

Investment property revenue is recognised on a straight-line basis over the period of the lease term so as to reflect a constant periodic rate of return on the net investment.

Interest revenue

Interest revenue is recognised using the effective interest rate method.

Grant revenue

A number of programs are supported by grants received from the federal, state and local governments.

Grant revenue that is not subject to conditions is recognised when control of the funds is obtained, economic benefits are probable and the amount can be reliably measured. If conditions are attached to a grant which must be satisfied before the Company is eligible to receive the contribution, recognition of the grant as revenue is deferred until those conditions are satisfied.

Dividend revenue

Dividends are recognised when the right to receive payment is established.

Rendering of services

Revenue in relation to rendering of services is recognised depending on whether the outcome of the services can be estimated reliably. If the outcome can be estimated reliably then the stage of completion of the services is used to determine the appropriate level of revenue to be recognised in the period. If the outcome cannot be reliably estimated then revenue is recognised to the extent of expenses recognised that are recoverable.

If the outcome cannot be reliably estimated then revenue is recognised to the extent of expenses recognised that are recoverable.

Revenue from training services is generally recognised once the training has been delivered.

Goods and Services Tax (GST)

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payables are stated inclusive of GST.

Cash flows in the cash flow statement are included on a gross basis and the GST component of cash flows arising from investing or financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows.

Comparative Amounts

Comparatives are consistent with prior years, unless otherwise stated.

Where a change in comparatives has also affected the opening retained earnings previously presented in a comparative period, an opening statement of financial position at the earliest date of the comparative period has been presented.

Contingencies

Contingent liabilities and assets are not recognised in the balance sheet but are reported in the relevant schedules and notes. They may arise from uncertainty as to the existence of a liability or asset or represent an asset or liability in respect of which the amount cannot be reliably measured. Contingent assets are disclosed when settlement is probable but not virtually certain, and contingent liabilities are disclosed when settlement is greater than remote.

New and Amended Standards adopted by the Company

The company has adopted all the mandatory amendments to Australian Accounting Standards issued by the Australian Accounting Standards Board. None of the mandatory amendments have had a significant impact on the company.

Accounting Standards issued but not yet effect and not early adopted by the Company

The Company has not early adopted and amendments to Accounting Standards and does not anticipate application of new accounting standards will impact the company.
